Bill Signing - Financial

Profit and Loss is in the Selectmen's Office to view and updated weekly.

Highway Department: Brief discussion about the hole by the spring on Spring Street. Bazarnicki is the point of contact for assigning driveway numbers. Driveway permit for Banks Road to be repaved is approved. Driveway permit application for Church Street to be repaved is still in review. Driveway permits that do not involve state roads need to submit driveway permit application through town as usual; if it involves a state road, a driveway permit will need to be submitted through NHDOT Driveway Permit Portal.

Gordon Sand and Gravel Blasting: Blasting notification is at least 24hr hour notice that is posted on the town website and bulletin board, typically the blasting has been on a Wednesday or Thursday and usually a month in between. There was a concern about truck drivers speed as well and if anyone is concerned to let the sheriff know.

10 High Street: Letter with RSAs about fines to be issued signed by Lounder to be delivered by Cheshire County Sheriff.

Town Office Renovations: Lounder to work on the door end of this week. Electrician will be coming August 1, 2025. Emergency lights to be replaced, need 14 identical lights. Discussed placement of motion detector lights.

Elderly Exemption; IRS Non-Filing Letter: Hrabovsky brought forward a concern for two applicants that were having a difficult time obtaining an IRS non-filing letter for their application.
