Highway Road Agent:

Grader – needs a new tire, \$1,080 per tire and it will need two tires, to be the same height.

Paving - should be starting this week for either Church Street or Banks Road.

Winter Sand – Bazarnicki to ask Gordon and Fulton's for estimates with silt content percentage and costs.

Map 405 Lot 48-3: Bazarnicki will assign a street number. Property owner to apply for a driveway permit on NHDOT Driveway Permit Portal, as the road is a State Road.

Town Office Renovations: Lounder is bowing out of finishing the town office renovations.

Dredging Fire Pond: Maguire states the fire pond does not need a permit. Maguire explains how he has removed the silt previously. Maguire placed a bid for silt removal; town will need two more bids for this project before it can begin.

Health Officer: Discussed about anonymity, Murphy's opinion is to not disclose information if asked, but can be revealed if the situation were to go to court and it could be revealed then. Still waiting to hear back from lawyer.
