**Dwayne Nettleton; Gordon Sand and Gravel - Blasting:** Lounder addresses his research findings from the State to the Nettleton's. Lounder read email about dust control from Michael Camacho who visited and spoke to the foreman at the pit.

Nettleton states he has a video from today of dust going across the road and an equipment operator gave him a hard time about videoing. D. Nettleton shows Lounder the video. D. Nettleton says he called the environmental protections to monitor. Lounder says he's been told by two different people that they are within their permits. L. Nettleton presents information about the regulations and effects of blasting. L. Nettleton reads about pre blasting regulations and signage/signals. D. Nettleton discusses more on previous statements about the seismic sensors. Lounder tells the Nettleton's they should provide their evidence to Deputy Matt Pardington. The Nettleton's want the company to be held responsible. Lounder tells the Nettleton's they should highlight what they think the company would be in violation of and show it to the Deputy. D. Nettleton shows the Selectboard pictures of the slab floor and Lounder told him he should bring that to insurance and to also talk to the State since this is State matter. Aver says this would be a good start to have a blasting ordinance in town. Lounder provides Nettleton's with the contact information for the Compliance Director Ellen Bilodiaou and Deputy Matt Pardington. Denehy states Fire Chiefs are not in charge of blasting unless there is an ordinance in town. The state agencies are the ones involved.
