#### **Highway Department:**

Salt has been ordered; the cost is around \$12,000.

Garage Door; Maguire states the door opener meeds to be replaced as it is over 25 years old. It is estimated at \$11,500 for the door and the door opener.

R&R Communications; Maguire has information on the coverage for the repeater. Maguire will need to get pricing for a tower/pole.

Lounder brings up the thought about adding a line to the budget; this would be to add another building to get the equipment out of the weather and Maguire says they need more space. Maguire to look into building ideas.

Hammond Hollow; Discussion of rebuilding the road. Maguire has talked to Arlington Paving. Money will need to be set aside for road construction.
